Copies of the meeting notice have been sent to the Municipal Clerk's Office and posted on the bulletin boards of the fire house and the post offices of Woodbridge and Sewaren. Mr. President, you may proceed.

Commissioner John C. Kenny led a pledge to the flag.

A moment of silence was observed for our departed members and for our men and women serving overseas.

Commissioner Todd Howell made a motion to approve the minutes of the January 8th, 2019 Regular Meeting and January 24th, 2019 Special Meeting which was seconded by Commissioner Patrick Kenny and carried unanimously.

Commissioner J.C.K.: We'll move into Committee Reports. Personnel and Liaison to the Volunteer Fire Company – Commissioner Moran.

COMMITTEE REPORTS:

PERSONNEL AND LIAISON TO THE VOLUNTEER FIRE COMPANY:

Commissioner J.M.: No personnel issues in the past month. We had promotions recently for Captains and Battalion Chiefs, Deputy Chief and hiring approved new recruit Firefighters. Training in the month of January: Career – 135 Hours; Volunteer Personnel – 127 Hours of training they completed. There are annual recertifications and updates. Career members also completed CPR Re-certification, many of the volunteers have and the rest will finish up with their final CPR Class on February 9th. A public CPR Class has been scheduled for March 13th and 14th or all day on March 16th. We current have fifteen residents signed up. That's my report Mr. President.

Commissioner J.C.K.: Okay, any questions for Commissioner Moran: We'll move on to Apparatus – Vehicles – Commissioner Howell.

APPARATUS - VEHICLES:

Commissioner T.H.: Mr. President I would like to report the following usage. The (inaudible) Boxes which are on the bottom of Engines 1 and 2 have been removed; they were deemed useless. Our ladder truck has been repaired and returned to service. Engine 1-3, the Pierce, has received the parts at Campbell and it should be back in service late this week or early next week. There's a current recall on Engine 2. Now the problem with recalls is that they will not fix the recall problem until the warning light comes on and they plug in the gizmo and they get a printout. They do not do preventive recalls but they are aware of this problem and Chief Charles Kenny has been on top of this problem. The rest of the report concerns all minor issues that were repaired and the full report is available in the minutes, I'd like to have it included Maria, thank you. That's the end of my report.

Commissioner J.C.K.: Okay any questions for Commissioner Howell? Okay we'll move on to Fire Prevention and Telecommunications and Hydrants – Commissioner Minkler.

FIRE PREVENTION:

Commissioner R.M.: Thank you Mr. President. My report is dated February 1st, 2019 which is covering January, 2019. Fire Investigations – 0; Total Inspections Completed in January – 51; Complaints and Spot Inspections – 4; Life Hazards – 8; Quarterly – 2; Semi-Annual – 2; Non-Life Hazard Uses – 10; Total Re-Inspections – 28; Permits Issued – 1; Total Amount Billed in January - \$2,223.00; Total Amount Collected in January – \$1,723.00. That's my report for Fire Prevention.

TELECOMMUNICATIONS AND HYDRANTS:

Commissioner J.C.K.: Okay, any questions for Commissioner Minkler? Okay we'll move on to Buildings and Grounds – Commissioner Kenny.

BUILDINGS AND GROUNDS:

Commissioner P. K.: Thank you sir. The monthly Building Report for February. The rear row lights near the ladder truck the bulb was going on and off. Billick was here and he replaced that. Survivor inspected the kitchen hood system. The sign was fixed in the Brook Street entrance of the firehouse. The eye hat lights in the library are flickering, the flash is good, (inaudible) looked at that. He adjusted the dimmer. DPW personnel came and looked at the door in the backroom. All the parts and stuff were ordered on that and as soon as they come in that will be replaced. It's about six weeks for all the parts to come in for all that stuff for the door and stuff. Dunigan was here due to a boiler malfunction. They did get that fixed and up and running. It

was determined that the auto feed gas valve was bad; it's working good now and Survivor inspected the building fire extinguishers. That is my report.

Commissioner J.C.K.: Okay any questions for Commissioner Kenny? We'll move on to report of Payroll and Bills.
