Commissioner J.M.: The usual time off; no other issues. The leg of the training Report – Completed 184 hours of training in February in the department and the Training Battalion Chief has been working with getting an S&A Conference Course. He's been looking at the one they have in Perth Amboy and has scheduled several training sessions throughout the spring some refresher and some new areas of training. Confirmed the ability of Live Burn and Lower Pressure Training for April and May for volunteers and the tours and forwarded the needed supplies for the public CPR Classes to be held in March. Scheduled training at Rutgers for the officers is continuing and that's my report Mr. President.

Engine 3 the pump was repaired and hydro tested which it passed and they are now replacing the faulty brakes on Engine 3. On Truck 1-2-6 the large diameter discharge valve seats were repaired. On Number 1-3-5 the mother board for the rear hour stick was replaced and our annual gear inspections were completed. The nozzles that we had were sold on govdeals.com. The payment was processed through the proper channels and other equipment that was put up on govdeals.com there were no bids on and it was disposed of. That's the end of my report. And the only other thing I will update us on is 400 School Street, as everybody knows, we terminated the lease there. Everything was moved out of there at the end of January and is in the new place up at Access Self Storage and come the spring when the weather breaks we will move on things to condense into the back a little bit. Deputy Chief John Golden: The Chief just gave me some. Lisa Lanza worked with Verizon. She reduced the monthly cost for about \$5.00 a month and they put us on a First Responder priority service which if the cell phone lines were down our service switches over to this priority line which means our phones will always work because the cell phones that we bought for the apparatus are all covered by this. The department raised the top safety award for the JIF including a \$2,500.00 decrease in our premiums due to the hard work and leadership of Chief Kenny and all the buying that the guys gave all the programs that he started, the gym equipment, things like that. The gym equipment was delivered like he said, Captain Mastanduno who took the lead. He was able to secure an extra 15% from Dick's when he went in to take care of the tax exempt information. So Mike did a lot of work on that and it really paid off. Like you said the nozzles were sold on govdeals.com. Captain Paul and Lisa were instrumental in the transaction. The price of the nozzles was \$726.00 that was brought back to the department. Captain Repace, Inspector Mangione and Battalion Chief Minkler and the members of Tour One were all guests, participants, at the Woodbridge High School Forensics Class. They went up and gave the class for a day. Captain Repace explained fire investigations and they actually performed a small demonstration out in front of the high school. The staff was very receptive of it and talking to the principal of Woodbridge High they really appreciated us going there. Like I said the shifts are involved in the Dr. Seuss Pre-School and Kindergarten movies. The tax and the agendas are the proposal for the new copier from Cannon so you'll see that. Captain Paul ordered the helmets for the volunteer officers that are expiring; he's working with the Chief on that. April 13th and May 4th will be the Live Burn at the Middlesex Fire Academy; signup sheets are down there. Thank Chief Paul and the Chief for working with the work gloves; that's taken care of and the Junior Fire Academy. The Chief plans on running the Junior Fire Academy the third week of July for all new participants from the school. The same set up is kids going into the 5th, 6th and 7th grades. And for the students that participated last year he's actually going to run a second week half day class so we don't overcrowd the first week so Lisa Lanza is working on that very hard. The Chief came me a little direction on it; I'm trying to help her out the best I can. A lot of things are going and that's my report.

Commissioner J.C.K.: Chief, how much for the copier?

Deputy Chief John Golden: I think the bid was \$6,700.00.

Commissioner J.C.K.: Okay and the buyer who is it?

Deputy Chief John Golden: The bid prices have both prices on the spec sheet. I can go get the folder but I know for the purchase price it was \$6,700.00 it was under State Contract. The maintenance plan was like \$20.00. We only received two bids one from Cannon and one was Xerox. The issue that we had with Xerox was we called back three times and the bid that they sent was an Excel sheet and when I asked to send something that we could print out and present to the Board he constantly sent me the same thing and the print was so small I couldn't read it. We asked for the State Bid List to be put on the bid. I got a copy of the State Regulations for bid processing. They were very personable people but the Xerox people seemed a little confused on how they wanted to sell these. The Canon salesman does a lot of business with Town Hall, they do a lot of business with Woodbridge, and are very familiar with the bid process. I could get you the price if it's not in your package.

Commissioner J.C.K.: It's not here.

Deputy Chief John Golden: Okay I'll get it to you before we leave but it came out to about \$7,000.00 total.

Commissioner J.C.K.: Okay we'll do Remarks, Comments and Questions from the Audience then we'll do the Executive Session and then you can get that when we come out then we can act on that.
