Commissioner Todd Howell made a motion to approve the minutes of the April 3rd, 2019 Regular Meeting which was seconded by Commissioner Robert Minkler, Sr. and carried unanimously.

Commissioner J.C.K.: Personnel and Liaison to the Volunteer Fire Company – Commissioner Moran.

COMMITTEE REPORTS:

PERSONNEL AND LIAISON TO THE VOLUNTEER FIRE COMPANY:

Commissioner J.M.: Mutual time off outstanding; nothing else at this time. Training Report: Career – Total Hours of training in April – 444; Volunteer – Total Hours of training in April – 79. Included in that were Officer's Training conducted by (inaudible) of the Officer's Training Program – They did lifetime drills during April at Middlesex Fire Academy for the career and volunteers. George Eppic is working on the refreshers for the (inaudible) intervention team. Operation's Class is going to take place this month and that's for career and volunteer members. The fire academy staff wanted information regarding HAZMAT operations and training has continued with the new hires and included apparatus operations. They have attended their (inaudible) class. That's my report Mr. President.

Commissioner J.C.K.: Okay, any questions for Commissioner Moran? Alright Apparatus and Vehicles – Commissioner Howell.

APPARATUS AND VEHICLES:

Commissioner T.H.: Thank you Mr. President. I would like to report tonight that all four pieces of apparatus are now back in service. There are a few minor small issues that have to be addressed yet with Truck 1-2-6 and with Engine 1-3; it'll be taken care of in this coming week. Also the Commander's car, 1-3-5, was sent to Malouf for what turned out to be a recall and service that was of no charge to the district. Also the Chief's car, 1-3-1, had some repairs done and is now back fully in service and that's the end of my report Mr. President.

Commissioner J.C.K.: Okay, any questions for Commissioner Howell? Fire Prevention, Telecommunications and Hydrants – Commissioner Minkler.

FIRE PREVENTION:

Commissioner R.M.: Thank you Mr. President. My report is dated May 1st, 2019 covering the month of April. Fire Investigations – 0; Total Inspections Completed in April – 80; Complaints and Spot Inspections – 3; Life Hazards – 21; Quarterly – 8; Non-Life Hazard Uses – 18; Total Re-Inspections – 104; Permits Issued – 6; Total amount billed in April - \$3,470.00; Total amount collected in April - \$1,128.00; Home Inspections – 1. That's my report on Fire Prevention.

TELECOMMUNICATIONS AND HYDRANTS:

Christopher Howell, Attorney: I spoke to Maria, our Clerk, about the ongoing audit by the State Comptroller's Office. She had provided some additional payroll records about a week and a half ago to the office and it's still ongoing and we haven't heard any word as to when it will be finalized.

Commissioner J.C.K.: Okay, Madame Clerk.

Maria Bucsanszky: Nothing.

Commissioner J.C.K.: Chief.

Deputy Chief John Golden: I got a report from the JIF. It's the Cost Control Report on April 4th. The only issue that they had was a bench grinder that needed to be permanently mounted. We had the work done today and it's permanently mounted. The Firehouse had its annual inspection and re-inspection by Fire Official Spillar. The bill for the repairs is on the Bill List to a shared service agreement with the township. The department participated in the township's Big Wheels. The apparatus MDTs and the mounting brackets are on order. The tablets have been delivered to put on Fire Inspector McNamara's desk, he said he would take control of them when he comes back; we're just waiting on the brackets. Gov.deals - The out of service equipment that was posted on gov.deals – as of January to this current date the total that was reimbursed back to the department was \$1,187.98 for 2019 and since it started the total net return for the district has been \$13,121.34. Dunigan was notified that they won the bid for the new boiler and they are scheduling a time to complete the work. The township fire officers held their monthly training here at the firehouse. The Chief was part of setting that up so it turned out to be pretty good attendance. We had a Health and Safety meeting with the members of Local 290. The volunteers, Chief Hapstak, Commissioner Moran and myself we were addressing some of the issues there. The Local has been wearing their Autism Awareness shirts for the month. Two members of the volunteer fire company are assigned for the Captain Buscio Exam so that's a positive thing; a number of career guys went. Helmets were issued to the volunteer chief as requested at the previous meetings so the chief has the new helmets for the officers and he'll distribute them as he sees fit. That's it.

Commissioner J.C.K.: Okay, any questions for the Chief?

Commissioner J.C.K.: Okay, New Business - Commissioner Minkler.

NEW BUSINESS:

Commissioner R.M.: Yes Mr. President. I'll do under New Business Preplanning for April, 2019. The report was submitted from Battalion Chief Markman to Deputy Chief John Golden. For the month of April each shift completed preplan of 158 Amboy Avenue which is known as Heavenly Auto Body Works. Each shift also completed a walkthrough of the new Ross Street School. The training hours were sent to Battalion Chief Robert J. Minkler, Jr. Building renovations at 1 Woodbridge Center Mall are in progress. Shifts are scheduled for a walkthrough in the month of May. The building construction has started on the new Pino's Restaurant at 280 Woodbridge Avenue. The preplans are in the Fire Prevention office. Each shift has been instructed to look them over and B.C. M. Minkler has started working on the project of converting fifty hydrants in the district over to the Stewart's Steamer Connections and that my report for preplanning.

Commissioner T.H.: None. I'll bring it up under the Executive Session the concerns of Carteret.

We then moved on to some various building and ground matters, we briefly spoke about that, and then we moved on to the progress of purchasing our new vehicles which are still on track to come in later this year. We then reviewed our retirement age policy and our physical exam policy and how those two play together. We then reviewed our long term relationship with Campbell's who is the maintenance and repair contactor for our apparatus and about their billing practices and purchasing of those and then we concluded on reviewing training procedures for our personnel and certifications of our personnel with regards to Hazmat operations. And that would conclude our Executive Session this evening.
