Commissioner Robert Minkler, Sr. made a motion to approve the minutes of the June 5<sup>th</sup>, 2019 Regular Meeting which was seconded by Commissioner Todd Howell and carried unanimously.

Commissioner J.C.K.: We'll start with Personnel and Liaison to the Volunteer Fire Company – Commissioner Moran.

#### **COMMITTEE REPORTS:**

# PERSONNEL AND LIAISON TO THE VOLUNTEER FIRE COMPANY:

Commissioner J.M.: Personnel – A letter was sent to the Chief from the Local regarding staffing. Training – Training hours in June were 297 Hours. The department hosted an I-300 Class which has been completed. Clone Senior to the Commander Class is scheduled for the last two weeks of September. The 2019 ISO Training report has been completed. The department has received a forcible entry prop. Some of the tours have been training with it and the Battalion Chief is working on scheduling training with the volunteer members on the prop. Cancer Awareness class has been scheduled in July as has the Anti-Harassment Training been scheduled for July and these classes will be for both career and volunteer members. That's my report Mr. President.

Commissioner J.C.K.: Okay any questions for Commissioner Moran? We'll move to Apparatus and Vehicles – Commissioner Howell.

#### **APPARATUS AND VEHICLES:**

Commissioner T.H.: Thank you Mr. President. The following will be my report: On Engine 1-1 and 1-2 there were minor repairs to keep everything in order. On Engine 1-3 they had preventive maintenance repair and repairs made to the No Smoke system, the Ward Diesel System and other minor repairs on Engine 1-3. Truck 1-2-6 — Additional preventive maintenance for there that vehicle's No Smoke Ward Diesel System was done and there were some minor issues that were addressed. And also on Truck 1-2-6 we replaced the four tires on the rear back axle. Also to report that on the Officer's Vehicle 1-3-5 we repaired the investigative channel on the radio; this was done by Pinnacle. There are a few other items that I'd like to note. We did receive a golf cart for our department use which was a donation at no cost to the district and some tools for lock breaking were placed into service on each apparatus and a couple of the gas meters were recalibrated and repaired. That's the end of my report Mr. President.
