Of course our First Ward Councilwoman Nancy Drumm is no stranger to the Woodbridge Fire Department, Nancy, our Councilman At Large Gregg Ficarra is here, our Deputy Police Director Joe Nisky is here and former Councilman Ken Gardner; I don't see anybody else who is elected. I also just want to thank the guy behind me, Emergency Management Coordinator Pat Kenny. This weekend we were at the Senior Olympics and a man in his 70s he already finished the 5K race, cycling race I should say at Woodbridge Center, and he just finished a 10K race and as he got to the finish line tried to step off his bike he went into cardiac arrest. He was dead; he flat lined he was dead. There was no pulse in his neck; there was no pulse in his wrist. Pat Kenny started working on him and got him back to life; literally saved the man's life. They were going to meet the ambulance halfway to the hospital to save time and as it turns out he got his pulse back, he started breathing and he was cognizant so they waited for the ambulance to take him to the hospital. We actually visited him today. The first question he asked when he came to that day was did I win; I'm not kidding you. His wife and his daughter said the whole story and today we went and presented him with his two silver medals but I cannot imagine the feeling any better than to know that you were the reason somebody is alive today so I'm going to congratulate EMS Coordinator Pat Kenny.
