Commissioner J.C.K.: Chris.

Christopher Howell, Attorney: Just 109 Green Street. The Board of Adjustments in Woodbridge here approved the Resolution on November 10<sup>th</sup>, 2022 to approve our Bulk Sale and Use Variance for the project at 109 Green Street and we published that notice in the newspaper pursuant to the law. It was published on December 2<sup>nd</sup>, 2022 and a copy of that was forwarded back to the town for their records. That's all I have on the update of 109 Green Street.

Commissioner J.C.K.: Okay, just so everybody knows too for 109 Green Street we had a conference call with the Bond Attorney and the people with the bonds. I think tomorrow they are going to put the application to go in front of the DCA and that would be for their regular meeting on January 11<sup>th</sup>, 2023 and that should be the final step before we can actually start to do bond anticipation notes and start it to go out. Maria, anything?

Maria Bucsanszky: Nothing.

Commissioner J.C.K.: Mike.

Deputy Chief Michael Balog: Nothing.

Commissioner J.C.K.: Nicole.

Nicole Grzeskowiak, Labor Counsel: Nothing.

Commissioner J.C.K.: New Business - Commissioner P. Kenny.

#### **NEW BUSINESS:**

Commissioner P.K.: I have nothing.

Commissioner J.C.K.: Commissioner Minkler.

Commissioner R.M.: Nothing at this time.

Commissioner J.C.K.: Commissioner Barcellona.

Commissioner J.B.: Nothing at this time.

Commissioner J.C.K.: Commissioner Moran.

Commissioner J.M.: Nothing to bring out at this time.

Commissioner J.C.K.: Chris.

Christopher Howell, Attorney: None other than the contract I prepared for the renewal of our agreement with the volunteers. Do you want to do that now or?

Commissioner J.C.K.: No, we'll go into Executive and then when we come out we can take care of that.

Christopher Howell, Attorney: Okay.

Commissioner J.C.K.: Maria.

Maria Bucsanszky: No, nothing.

Commissioner J.C.K.: Mike.

Deputy Chief Michael Balog: Nothing.

Commissioner J.C.K.: Nicole.

Nicole Grzeskowiak, Labor Counsel: Nothing.

Commissioner J.C.K.: Alright, tonight we are going to introduce the 2023 Budget. Maria emailed them to you last week for your review and Maria do you just want to go over the highlights.

Maria Bucsanszky: For the Budget itself?

Commissioner J.C.K.: Yes.

Maria Bucsanszky: Okay, we are going to need to pass three Resolutions really for the budget. The first one will be the 2022-12-4. We will be going for a Levy Cap Referendum which is added into the taxation amount for the budget. We are going to be seeking an additional \$3.435 million for additional personnel fringe, turnout gear etc. If we can pass this first.

Commissioner J.C.K.: Sure.

Maria Bucsanszky: Okay, I would need a motion for the Levy Cap Referendum resolution.

Commissioner Robert M. Minkler, Sr. made a motion to approve Resolution 2022-12-4 which was seconded by Commissioner Jay Barcellona and carried unanimously by a Roll Call vote. Commissioner John C. Kenny – Yes; Commissioner Robert M. Minkler, Sr. – Yes; Commissioner Patrick Kenny – Yes; Commissioner Jay Barcellona – Yes; Commissioner Jeffrey Moran – Yes.

Maria Bucsanszky: Then the next Resolution would be Resolution 2022-12-6 which is we held a Special Meeting last Friday in order to have the public's opinion on adding three Capital Questions to the 2023 Budget and all three questions passed and they are now included in the 2023 Budget in detail. I would need a motion to approve the results of the Special Meeting.

Commissioner Jeffrey Moran made a motion to approve Resolution 2022-12-6 which was seconded by Commissioner Jay Barcellona and carried unanimously by a Roll Call vote. Commissioner John C. Kenny – Yes; Commissioner Jay Barcellona – Yes; Commissioner Jeffrey Moran – Yes; Commissioner Robert M. Minkler, Sr. – Yes; Commissioner Patrick Kenny – Yes.

Maria Bucsanszky: And then the last one with the Budget for 2023 is the actual introduction of the Budget. Resolution 2022-12-5. Total Revenues including the Levy Cap Referendum is \$17,077,310.00, the Taxation is \$15,288,244.00 and Total Appropriations is \$17,077,310.00. I would need a motion.

Commissioner Jeffrey Moran made a motion to approve Resolution 2022-12-5 which was seconded by Commissioner Jay Barcellona and carried unanimously be a Roll Call vote. Commissioner John C. Kenny – Yes; Commissioner Robert M. Minkler, Sr. – Yes; Commissioner Patrick Kenny – Yes; Commissioner Jay Barcellona – Yes; Commissioner Jefffrey Moran – Yes.

Maria Bucsanszky: Then I will need one more for 2023 as a Temporary Resolution for the first two months of operations next year. Its 2022-12-3. I need a motion.

Commissioner Robert M. Minkler, Sr. made a motion to approve Resolution 2022-12-3 which was seconded by Commissioner Jay Barcellona and carried unanimously by a Roll Call vote. Commissioner Robert M. Minkler – Yes; Commissioner Patrick Kenny – Yes; Commissioner John C. Kenny – Yes; Commissioner Jay Barcellona – Yes; Commissioner Jeffrey Moran – Yes.

Maria Bucsanszky: Then I need, to backtrack for the Local Finance Board for the Bond Counsel. We definitely need to pass Resolution 2022-12-1 which would give the authority for the Bond Counsel and the Financial Advisor to submit the application to the Local Finance Board and proceed with bonding.

Commissioner Robert M. Minkler, Sr. made a motion to approve Resolution 2022-12-1 which was seconded by Commissioner John C. Kenny and carried unanimously by a Roll Call vote. Commissioner John C. Kenny – Yes; Commissioner Robert M. Minkler, Sr. – Yes; Commissioner Patrick Kenny – Yes; Commissioner Jay Barcellona – Yes; Commissioner Jeffrey Moran – Yes.

Maria Bucsanszky: Should I do the last one?

Commissioner J.C.K.: Sure, why not.

Maria Bucsanszky: Okay, this is to transfer funds in the 2022 Budget. Resolution 2022-12-2.

Commissioner Robert M. Minkler, Sr. made a motion to approve Resolution 2022-12-2 which was seconded by Commissioner John C. Kenny and carried unanimously.

Commissioner J.C.K.: Any questions? Okay, so then I think we got everything done, right?

Maria Bucsanszky: Correct, the public hearing will be January 17<sup>th</sup>, 2023 on the Budget.

Commissioner J.C.K.: So first of all our Regular Meeting is not going to be in the beginning of January it is now going to be January 17<sup>th</sup>, 2023 at 7:00 P.M. and that is because we need to leave more time now for the State so instead of having two meetings we'll just have one meeting. Okay, Remarks, Comments or Questions from the Audience.

I want to wish the Chief his best in his retirement. He did get the Interlocal working for Auto Aid and I think at this point Commissioner Moran has a Resolution.

Commissioner J.M.: 2022-12-7 naming Deputy Chief Michael Balog as the Provisional Chief of the department beginning January 1, 2023.

Commissioner Jeffrey Moran made a motion to approve Resolution 2022-12-7 which was seconded by Commissioner Robert M. Minkler, Sr. and carried unanimously.

Commissioner J.C.K.: We also have Resolution 2022-12-8 which was the contract with the agreement with the Volunteer Department.

Commissioner Robert M. Minkler, Sr. made a motion to approve Resolution 2022-12-8 which was seconded by Commissioner Jay Barcellona and carried unanimously.

Commissioner J.C.K.: Okay, motion to adjourn.

Commissioner Robert M. Minkler, Sr. made a motion to adjourn the Regular Meeting at 8:40 P.M. which was seconded by Commissioner Jay Barcellona and carried unanimously.

#### FIRE SERVICE PROTECTION AGREEMENT

This agreement, by and between THE WOODBRIDGE BOARD OF FIRE COMMISSIONERS OF FIRE DISTRICT NO. 1 hereinafter referred to as COMMISSIONERS; and THE WOODBRIDGE FIRE COMPANY NO. 1 hereinafter referred to as FIRE COMPANY will run from December 1, 2022 through December 31, 2023.

WHEREAS, N.J.S.A. 40A:14-70.l (b) authorizes the Commissioners of a fire district to contract with a volunteer fire company or companies for the purpose of extinguishing fires, upon those terms and conditions as shall be deemed proper; and

WHEREAS, the Commissioners have negotiated agreement(s) with the fire company or companies within their jurisdiction upon terms that are fair and proper for the providing of fire protection services to the fire district; and

WHEREAS, the term "FIRE COMPANY" shall reflect a singular entity as applicable to this particular agreement.

NOW THEREFORE, it is agreed, in consideration of the payment to be made as herein described and the exchange of mutual promises, as follows:

- (1) The Fire Company will extinguish fires within the fire district or within such other areas or territories as may be contracted for by the Commissioners, or pursuant to mutual aid agreements which have been approved by the Chief of the Fire Company. For the purposes hereof, the term "extinguishing fires" shall be used in its broadest and most universal sense.
- (2) Nothing herein shall be construed to increase any liability on the part of the Fire Company to the public for errors or omissions in the performance of its duties hereunder, or pursuant to any other requirement.
- (3) The members of the Fire Company in performing fire duty, shall be deemed to be exercising a governmental function.
- (4) The members of the Fire Company shall be under the supervision and control of the Commissioners, and the Fire Company may not take any action which is contrary to law or to the by-laws or official actions of the Commissioners.
- (5) The Commissioners may discipline any member of the Fire Company whose actions are contrary to law or to the by-laws and/or in violation of any rule, regulation or standard operating procedure.
- (6) The Fire Company shall provide volunteer firefighters to adequately provide fire protection for the District. The Company shall provide such personnel as may be available for the specified purpose. The firefighters shall be trained in

accordance with the standards set forth by the New Jersey State Division of Fire Safety and the Occupational Safety and Health Administration (OSHA) 1910.120. The Commissioners shall provide, at a minimum, the required training and equipment mandated by the New Jersey State Division of Fire Safety.

- (7) All firefighters 65 years of age or older who wish to be IDLH certified as an exterior firefighter must fill out a questionnaire every year and submit to a physical exam at 65 years of age, 68 years of age and then every year starting at 70 years old. In addition all firefighter of the age of 65 or older must submit to a stress test and thereafter on the Department doctor's recommendation. be trained in accordance with the standards set forth by the New Jersey State Division of Fire Safety and the Occupational Safety and Health Administration (OSHA) 1910.120. The Commissioners shall provide, at a minimum, the required training and equipment mandated by the New Jersey State Division of Fire Safety.
- (8) The Fire Company shall be expected to strictly adhere to their by-laws and the comprehensive written standard operating guidelines that are maintained by the Commissioners.
- (9) In addition to the payment to be made in accordance with the schedule by the Commissioners to the Fire Company pursuant to this agreement, the Commissioners shall provide worker's compensation coverage for all volunteer firemen of the Fire Company and liability insurance coverage for the Fire Company. The Commissioners shall also provide insurance for apparatus, vehicles, equipment, and the firehouse or other structures owned by the Commissioners.
- (10) The Commissioners shall provide semiannual payments to the Fire Company pursuant to appropriations allocated in the yearly budget. The Commissioners require submission of a voucher as a prerequisite to payment. In addition to the aforesaid compensation, the Commissioners shall provide a Length of Service Program (LOSAP) to the personnel of the Fire Company. Any further reimbursements and/or appropriations to the Fire Company must be approved by the Commissioners.
- (11) Notwithstanding anything to the contrary herein contained, the Commissioners will not interfere or seek to regulate the internal administration of the Fire Company.
- (12) The Commissioners shall provide life insurance for the members of the Fire Company. Any insurance, once in force, may not be terminated by the Commissioners without furnishing 30 days' notice to the Fire Company.
- (13) The Fire Company will house, if applicable, any apparatus, vehicles or equipment furnished by the Commissioners in a safe and secure manner, will

observe any rules or regulations promulgated by the Commissioners for the maintenance, storage and use of said apparatus, vehicles and equipment and shall utilize same only in accordance with procedures established by the Commissioners and to effectuate the purpose of this agreement.

- (14) This agreement is contingent upon adequate funding being provided in the annual budget and by appropriation of the Commissioners.
- (15) Unless either party furnishes 60 days' notice of non-renewal of this agreement prior to its expiration, this agreement shall continue on a yearly basis following the expiration date herein, provided same shall be subject to termination by either party upon 30 days' notice.
- (16) If any article, section, paragraph, sentence, or clause of this agreement is determined to be invalid, same shall be deemed severable and the remainder of the agreement shall survive unless such invalidated language is material to the purposes and intentions of the parties (in severability clause).
