Commissioner J.C.K.: I need a motion to approve the minutes of the Regular Meeting of February 1st, 2023.

Commissioner J.C.K.: Okay, now we'll move into the election certification.

Maria Bucsanszky: Whereas the Board of Fire Commissioners, Woodbridge Fire District 1 Woodbridge held the annual election in accordance with N.J.S.A. 40A-17-72 on February 18th, 2023 and Whereas this election was held in the time and manner as prescribed by statute therefore be it resolved that the results of the election were as follows: For Fire Commissioner – Three Year Term – John C. Kenny 382 votes; Patrick Kenny 361 votes and there were six write-ins. Public Question No. 1 – Shall the Fire District No. 1 2023 Fiscal Year Budget be adopted with total revenues of \$13,642,310.00 which includes the \$11,853,244.00 to be raised by taxation and Total Appropriations of \$13,642,310.00, Yes votes were 233; No votes were 213. Public Question No. 2 – Shall the Board of Commissioners of District 1 and the Township of Woodbridge be authorized to increase the 2023 amount to be raised by taxation in the Fire District Annual Budget by \$3,435,000.00 as provided by N.J.S.A. 40A-4-45.45 not withstanding that its amount to be raised by taxation will

exceed the 2 percent increase limitation. Yes votes -197; No votes -231. Motion to certify.

Commissioner John C. Kenny made a motion to certify the results of the Fire District 1 election which was seconded by Commissioner Jay Barcellona and carried unanimously.

Commissioner J.C.K.: Now we'll go into relief organization and first we'll do the Oath of Office for the two new commissioners so we'll take care of that.

Commissioner J.C.K.: I'd just like to make a quick statement. As you know we had a lot of people this year at February's election. Yes the question that we were trying to increase staffing did not pass but yet it was not that far off in numbers. This entire Board strives to try to make sure that we have the most safest department out there with adequate staffing. The entire department is one unit and it all takes everything. We need, from our Career that work a day, as we need from the Volunteers, to help hold the line. There's a support role for them as there is a support role for the Career and we need that and we can see by the numbers that we need to do a little bit better educating and the Board is going to strive to do that this year and get the public to understand a little bit better of what our fire service provides and what we can do and we are still planning on staying the course of all the items that we already have tried to start and continuing this year with setting the Rescue up and running and getting that operation going. I know Chief Balog is working on trying to get moving on the winner for Swiftwater Rescue which we had planned from last year and we continue with that so just to be on record this Board is still striving to keep moving forward to keep striving to get the department out there. With the leadership of the Chief and our new Deputy Chief we will get there. We just need to educate a little bit better. That is what it seems to be so we will do that. Does anyone else have anything that they want to add on to that you're more than welcome.

Commissioner R.M.: You said it all.

Commissioner J.C.K.: Okay, we will move onto Committee Reports – Personnel and Liaison to the Volunteer Fire Company – Commissioner Moran.

In conjunction with the Chief they have been moving forward with the Promotional Results, the test results, and we are moving forward with that. Also, we have the LOSAP qualifiers list which consisted of four persons this year.

Commissioner J.C.K.: Okay, so we'll post that for thirty days and if there are no objections then we will move forward after the thirty days are over Chief.

Commissioner J.M.: Other than that, just the rest of the report be placed into the minutes in its entirety.

Commissioner J.C.K.: Okay, any questions for Commissioner Moran? Okay, we will move on to Apparatus and Vehicles – Commissioner Minkler.

From The Audience.

REMARKS, COMMENTS OR QUESTIONS FROM THE AUDIENCE:

Captain Paul DeLeo: Mr. President, my name is Captain Paul DeLeo with the Port Reading Fire Department located at 10 Beacon Street. I wanted to come here and give a personal debt of gratitude to the Fire District as a whole. On February 2nd we had a major catastrophe in Port Reading on a 180 foot storage tank full of gasoline that the internal floating roof sunk creating a severe potential hazard for our community, Port Reading, as well as the neighboring communities for environmental hazards as well as everything else. Patrick Kenny, I want to personally thank you for your role as Emergency Management Coordinator and I also want to thank the Fire District as a whole because they provided the logistical support resources expertise from your management to your Chiefs and congratulations to both of you, their management, their fire department, the Rank and File and everybody. They were out there for multiple days with the Fire Department battling the elements and doing things that this District doesn't get to do all the time and our District doesn't get to do all the time. It's something that we train upon. I want to put a special thank you out to Battalion Chief Mark Minkler who worked side by side with me during the four or five days of freezing cold weather. We rotated out shifts, we did the best work we could and it turns out that what we did was impactful, was matterful and actually probably saved a later catastrophe which we had later on when we the tank actually caught fire. Talking to the experts our foam application that we did to suppress those vapors probably reduced that secondary fire to something that could be much more manageable. But I cannot extend enough gratitude to this Board and your Fire District to being such good partners for Port Reading Fire Department. I don't the

Port Reading Fire Department but that day I did. I was Incident Commander and it kind of rolled over to each day so I thank the Board for your continued support, your logistical support, your expertise that your entire Fire Department from the Rank and File from the bottom all the way to the top and especially Mark Minkler. If there is anything I could ever do for this District please call me anytime and I will be there. It was the hardest work and to see those firefighters out there in those subzero temperatures through the night for four or five days and then have to pick up all the gear and organization and demobilize it was challenging for everybody and you guys should be proud of what you have and I want to act on your words for moving forward. There is a definite reason to build your department because it is so good right now, it was such an asset to us and I hope the next time you have the opportunity to build it you can build it. Just keep doing what you're doing because we appreciate it. We would like to build our department too but I can't thank you guys enough. I'm sorry if I'm getting a little choked up.

Commissioner J.C.K.: No, no it's okay.

Captain Paul DeLeo: It's really nice to practice those skills all the time and then to get to apply them in an area where you usually don't get to do those things. But I know I show a lot of you Chiefs out there all the way down the line so I can't thank you guys enough.

Commissioner J.C.K.: Thank you for coming, it was really nice. Chief, can you please make sure that the Rank and File gets those communications.

Chief Michael Balog: Absolutely.

Commissioner J.C.K.: Thank you. Okay, Chief Fee.

Commissioner J.C.K.: Okay, anybody else?

David Hines, President Local 290: I want to congratulate the Commissioners on their recent election. It's a good working team that we have here in moving the department forward. An area of concern that has come up though is with the special question that came up for staffing for safety for the community for the Career Firefighters, for the Volunteers, for the firefighters that come visit the community I was dismayed to observe it myself and to get reports back from people that the management of the Volunteer Fire Company actively spoke negatively about adding staff. You know a May Day for volunteer and career firefighter is a horrible thing. You saw what happened up in Buffalo and I was very upset to see that come out of an organization

that the union has always tried to work with to bridge gaps, to embrace the younger newer members and try to keep a harmonious environment. To see that actively go on was very disheartening. It came from people in the community, it came from other volunteer firefighters telling me what was going on and I was just very disappointed in that and I hope that we wouldn't have that kind of thing going on. Everybody has their right to their vote as we all know here but to have, you know, somebody from the career side did that as a supervisor I'm sure it would cause problems and the volunteer fire company has 1.5 volunteers that come out to calls so I don't understand what their end game was but I hope that maybe they re-evaluate their thoughts on this. That's all I have on that. Then I just had something that I wanted to talk about in closed session if possible.

Commissioner P.K.: Just to echo what you just said I think it was on both sides because you had retired members on your side, let's clear the air, it's not on one side but both sides that were kind of going against it negatively and some active members.

David Hines, Local 290: And that's why I said everybody has a right to their own opinion and feelings and actions. We don't want to suppress that but when it comes from the fire company's management that's disheartening. And I've had conversations with career firefighters on this also. It's not easy.

Commissioner P.K.: I can say right now as a Board member, my 25th year now, working with the new Chief we've already had conversations with the Board to, even though the question went down, to booster the roles even more on the career side for the safety.

David Hines, Local 290: And we appreciate that absolutely.

Commissioner P.K.: And we actually have other things that are going on.

David Hines, Local 290: And the union would like to be a partner with that. We have a lot of resources that we can bring into the community.

Commissioner P.K.: If he needs you he's going to reach out to you because he's running with it in a good way. If you want to move this District forward we're going to do what we got to do within the law that we can do so we can do better and make sure that the safety is there for everybody.

David Hines, Local 290: I thank you for that.

Commissioner J.C.K.: Okay, anybody else? Okay I need a motion go to Executive Session for a minute to address some personnel and matters. I

Commissioner Robert Minkler, Sr. made a motion to go into Executive Session for some personnel and matters at 7:30 PM which was seconded by Commissioner Jay Barcellona and carried unanimously.

Commissioner Robert Minkler, Sr. made a motion to return to the Regular Meeting at 7:45 P.M. which was seconded by Commissioner Jay Barcellona and carried unanimously.

Commissioner J.C.K.: Mr. Attorney, do you want to give us a summary?

Christopher Howell, Attorney: Yes, tonight's Executive Session was a brief session. We first heard from the President of Local 290. He just raised issues about the Relief Association around the formation of Company 2 for career members and we discussed that.
